 - i. Agent updated The Board that The State is required to give Municipalities the ability to opt out of aerial spraying only when deemed necessary.

- **a. Vote:** Consultants can charge their own Individual prices for Bottom Hole and Final Inspections when Agent is not available, and installer wants to move forward. Installer will pay the town for the inspection and the town will pay the consultants.

b. Agent Report:

- i. Beavers
 - 1. Brockton Water commission alleges dam is operational. The water is flowing much better, and Division of Fisheries conducted the remediation of the Beaver population and dam removal involved using an excavator.
 - 2. Budget Request of \$5000 to be held and managed by the BOH to provide a cushion to prevent a potential budget over expenditure in the future.
 - 3. In this case there was no cost to the Town. In the future either the property owner and or the Town is responsible for the costs. The options for the services needed are being considered by the Health Agent for the Boards review.

ii. 638 Monponsett Street update

1. Agent updated Board. The House is falling, and Building, Health, Fire, and residents conducted site visit. The group determined a need to

demolish for safety reasons. The Town and Rockland Trust will provide funding. As an unoccupied residence Building started the process to demolish.

2. Once all legal issues are approved the home will be demolished.

a. A resident stated they thought a fence may remedy these issues. Agent noted that putting a fence around the property would not prevent the structure from potentially falling onto the sidewalk or Rt. 58.

iii. 163 Plymouth Street update

1. Agent updated The Board on 163 Plymouth Street:

a. Case is closed and the Town received \$5,000 recovery of fines from Fannie Mae.

b. Currently the junk, trailer, and occupancy are not in violation of the housing code. This case is proof of why we as a Board use enforcement by fines as a last resort. When the parties involved are willing to meet with us, we can provide guidance for resolution of a problem and uphold the Law, Regulation, and codes.

c. Attorney fees did out way the recovery. The determination to settle was based upon legal counsel advise as how the court may rule is

unknown.

d. Agent recommended the Board to consider the Town to add a By Law modeled around the Braintree Anti-Blight Ordinance, which was provided to The Board for review.

e. The Select Board would need to approve as a Town By-Law is not specific to the Board of Health. The proposal allows each agency (Building, Fire, Board of Health) in the Town to write corrective orders to enforce compliance.

f. If order conditions are not satisfactorily completed and the Town undertakes corrective action the recovery cost can be leaned on the property/owner.

iv. COVID Update

1. Agent updated that the number of cases is on a decrease, but it is not gone. There have been No Hospitalizations or Deaths.

2. Agent state that Winituxsett Day care had two children from the same family test positive on 5/2/2022. The Director notified DPH and Board of Health. DPH gave recommendations and deferred decision the Local Board of Health. Agent allowed facility to remain open, notify parents and use current protocols.

a. In addition, test kits were provided to facility and each parent/child must test negative before attending. The next morning 5/3/2022 the director notified me that the other teacher had tested positive. Agent has decided to air in an abundance of caution and close the facility until Monday 5/9/2022.
