He stated that many towns hire Health Agent's at their own will and can be dismissed for any or no reason, and some towns appoint every three years. Agent wanted to use this as an opportunity to bring this up because other jobs within the Town also have one-year appointments, and there is a potential to lose talent.
 - i. The Board discussed and would like to move to the next step of making the term 3 year as that would add security. Employees undergo a review every year, and if there is an issue it should be addressed, given a PIP (Personal Improved Plan) violation of policy would still result in immediate termination and the opportunity to correct job performance issues.
