a. Candice Greene would like to discuss the possibility of changing the meeting time back to 6:30pm.

b. Porta-potty: Does Cled's Tree or 0 Monponsett require a porta-potty.

i. Chair asked Agent if there were any workers present at Cled's Tree. Agent responded that other than one instance, he had not observed anyone on the property at Cled's. Agent also did not observe any workers at 0 Monponsett. He has conducted multiple site visits to both properties.

ii. Agent noted that human health and environmental concerns are a top priority, so if there are employees working on site, there should be a

port-a-potty. The Board discussed.

iii. Chris Winiewicz, who was present at the meeting wanted to express his concerns to The Board.

1. Agent asked Mr. Winiewicz to wait until The Board completed their vote on Porta-a-Potty's. In adhering to open meeting law this complaint was reasonable to be brought up for discussion afterwards

A Motion was made to require a port-a-potty at Cled's Tree Service and 0 Monponsett Street.

c. Discussion: Cled's Tree.

i. Health Agent made it clear that this could not be voted on.

ii. Mr. Winiewicz approached the microphone and expressed his concerns. His concerns included loud noise, tub grinder, reverberation of the machines, and zoning. He mentioned that his concerns have been expressed for the past year and a half to two years.

1. He presented photos to The Board to indicate where his house

is in relation to Cled's Tree Service.

iii. Health Agent addressed that for The Board of Health, this is a Noise Nuisance Complaint. Although other Boards may be involved with these concerns, Agent stated that we will tap into every resource The Town has such as Zoning, Planning, Police Department, Fire Department and DEP to assist within the Jurisdiction of the Board.

iv. Agent added that he believes that Cled's should be given every opportunity to demonstrate that the use of the grinder does not present a nuisance and allow him the ability to correct any issues.

d. Admin. Report:

- i. 06/08/2021 E. coli Beach Testing Results have all tested well below DEP guidelines. Monponsett Pond Beaches remain open.
 - 1. Agent updated that he received preliminary results today, and Halifax Beach (*Richview Ave/Eleventh Ave*) had a result that was just above the recommended levels. He will receive an official confirmation tomorrow, Thursday June 17th if that beach must be closed.
 - **a.** Torrential rain, duck population, and dog waste are also potential causes in slightly elevated levels.
 - i. All other beaches preliminary results were great.
- ii. Rabies Clinics Admin. spoke to the Amanda, Animal Control Officer. She stated she will reach-out to a mobile clinic to see if they are available to do a rabies clinic.
 - 1. The Board discussed. Admin still working and researching for the best possible options.

e. Agent Report:

- i. COVID-19 Update.
 - 1. Agent updated The Board that COVID-19 response has been going well, vaccinations are much more available and local for those that decide to get a vaccine.
 - **a.** He suggested that people check with their doctor to make sure they are the right candidate for vaccination, and if not, to follow the recommendations by the CDC. Social distancing, hand washing, and masks are a must.)
 - i. We must all work together as a community to prevent COVID-19.
 - 2. Health Agent brought up the discussion on amending the regulation on single cigar sales and increases/reductions in fees as discussed at the previous meeting. He stated that a hearing is required. He suggested listing all the changes and posting for the hearings admin. will send to the newspaper.
