- Member King-Cavicchi stated that she spoke with Christopher from Representative LaNatra's office today. The discussion with Mr. and Mrs. McAndrews at the last meeting regarding the erosion taking place in the Lake St. has come to their attention and Rep. LaNatra would like to set up a meeting with the Conservation Commission and all the residents on Lake St. to discuss some long-term solutions. Even if the wall is replaced, the pond's water level with the Town of Brockton is still going to remain an issue that will make the wall repairs temporary. Chair Evans still believes that Mr. and Mrs. McAndrews should submit an NOI. Member King-Cavicchi expressed that there are grants that may be available to residents for these types of repairs. Member King-Cavicchi stated that she would be willing to help with the grant submission while she was out on medical leave. Member Hadorn suggested that if King-Cavicchi wanted to make up a list of places that residents could look to find grants available for funding, he would support that. Member Hadorn and Chair Evans stated that they would not support King-Cavicchi personally helping residents filing grants as it could expand quickly and would create a question on where to draw the line.
- ConCom Secretary asked if there would be a possibility of a Conservation Agent in the future. It
  is difficult for her to keep up where she must research the laws when something comes up. An
  agent would be helpful as they are aware of the laws and what violations are necessary in certain
  situations.
