



Halifax Conservation Commission Meeting Minutes October 17, 2023

Present at the Meeting: Edward Lane, Co-Chair, Steve Goodman, Member, Melanie Martin-Plant, Member.

Absent: Kathy Evans, Chair, Kimberley King, Secretary.

Vice Chair Lane calls the Halifax Conservation Commission meeting into session and states members present.

The Conservation Commission meeting opened at 7:00pm.

Hearings:

- **7:05pm: 111 River Street – ANRAD – Continued Hearing:** Rebecca Baptista
 - Approval of Bordering Vegetated Wetlands (BVM).
 - Ecosystems Solutions Continued Peer Review.
 - Rebecca Baptista, Representative for Silva Engineering presented the Abbreviated Notice of Resource Area Delineation (ANRAD) and Ecosystem Solutions peer review to the Board. Request to continue so that Mr. Thompson and the Botanist can do a site-visit to ensure an accurate delineation.

- **7:10pm: 57 Lake Street – RDA – Continued Hearing:** Addition to existing Deck. Owner Michael Maurice and Contractor Daniel Edwards, Handyman Connections were present.
 - At their 10/03/23 the Board requested more detail information on the plan.
 - The Board discussed the difference between a Request for Determination of Applicability (RDA) and a Notice of Intent (NOI). Administrative Assistant will check with DEP as to what the property process for each are.
 - The Board, Mr. Maurice and Handyman Connection discussed the materials, size, specifics of the deck and erosion control measures.

A motion was made to approve the Request for Determination of Applicability (RDA) with the condition that if a Notice of Intent (NOI) is required by DEP, the applicant will be required to follow and submit that process as required.

Discussions and Actions to be Taken:

- **Conservation Commission Policies:** Discussion to consider policies for the following:
Chair Evans requested discussion on the following:
 - Whenever wetlands are disturbed, it is required to be replaced by a 2-1 replication.
 - Whenever new construction is within the 100' buffer zone, a post and rail fence is required to be placed at the 50' "no touch" buffer zone.
 - Continue to next meeting when Chair Evans is available.
- **250 Ligan Street:** Morse Brothers Bog 10/04/2023 Site-Visit:
 - DEP received a complaint from an abutter of 250 Ligan Street/Morse Brothers Bog alleging that dirt/manure is being dumped/stored on the drinking water wells at the property and alleges that it is affecting their water.
 - Branden Costa, DEP, Conservation Chair Evans, Health Agent Valery and Brendan Moquin, Controller for Morse Brothers conducted a site visit on 10/04/2023.
 - The Board discussed a complaint at the property that was submitted to DEP. Conservation Chair Evans, Health Agent Valery and Brendan Moquin, Controller for Morse Brothers conducted a site visit on 10/04/2023. Chair Evans is waiting for DEP's report on any violations DEP witnessed and their recommendations as to how to move forward if any violations were witnessed.
 - Member Goodman stated his personal view and not a representative of the Conservation Commission Board on the wells and alleged storage of dirt/manure, previous complaints and site-visit in June 2023 and Morse Brothers Earth Removal Permit submitted.

Other Business: **Any other unscheduled business following posting of this Agenda.

- Tom Alger, 340 Plymouth Street updated the Board that they are progressing with an easement with the Peck's, regarding putting in the Storage facilities. Both the Peck's and the Alger's engineers have looked at the piping that will cause abandoned ditches.
 - The Board and Mr. Alger discussed the pipes, abandoned ditches, flooding, any wetlands, flow of water, engineer's report that water will not collect there any longer. The Board requested a letter from the engineer stating that any drainage issues will be alleviated.
- **129 Oak Street:** Complaint Update: Water run-off.
 - Admin informed the Board that she is still coordinating a site-visit.
- **111 Lake Street:** Complaint Update: Homeowners within 50' of buffer zone, pushing piles and clearing into the stream.

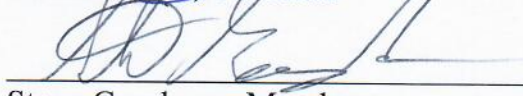
