**Reserve Fund Transfer:** Legal Account that was recommended at the last session was short and needs to be revised tonight. The amount requested is \$40,000.

Discuss and Recommend Remaining FY24 Town Articles/Expenditures: Todd asks Cody about the AC unit for the schools and if they have submitted their final cost. This has not been turned in yet but are hoping to have it prior or at the town meeting. Next Cody addresses an error in the spreadsheet for the warrant. They are now able to leave about \$40,000 in the levy. They are also able to increase the OPEB Trust by \$5,000 and will bring that account to \$44,000 not \$40,000 which was previously expected.

Next is Article 8 for the raise and appropriate transfer in the amount of \$260,000. This was previously voted by the committee at a lower number so the committee would need to revote on this item.
