TALENT BANK FORMS OF FINANCE COMMITTEE OPEN POSITION CLOSED 6/30: The finance committee received one talent bank form for the current vacant position.

FINANCE COMMITTEE CANDIDATE INTERVIEW: WILLIAM J SMITH: The candidate, Mr. Smith, joins the meeting remotely. Todd asks Mr. Smith to share his professional background with the committee and why he would be interested in joining. Mr. Smith shares he has been a resident of Halifax since 1989. He also has 37 years in the municipal government. His current position is the chief of police in Holbrook MA. He has experience operating 4-million-dollar budgets and is familiar with the roles and responsibilities of the finance committee. Mr. Smith will be retiring in the spring from his current position and will now have the time to volunteer and give back to his community. Todd thanks the candidate for his interest. The committee will discuss and take a formal vote during the next meeting.

LINE-ITEM TRANSFERS REQUESTS: The first line-item transfers of the night is from the Police department. The department is requesting \$503.75 be transferred from the Police Training Account into the Police Chief Salary

Account. The reason for the transfer is due to the Juneteenth federal holiday not being in the Police Chiefs contract. This has been corrected for the new fiscal year.

Next requests come from the School Department. They are requesting the transfer of \$33,321.25 from the Vocational School Education – Transportation Account in the Elementary School – HES Expense. The reason for the request is due to the cost to run the program at HES including the salary of the teacher and para. They also had unexpected long-term leaves including three maternity leaves. Other expenses included are long term subs, homeless transportation and interpreting services.

The school department also requested the transfer of \$80,000 from the Special Needs Tuition to the Elementary School – HES Wages. This is needed because the school is now providing these services in the elementary school and not transporting students to surrounding towns. This allows for less transportation expenses, smaller classroom sizes and allows students to remain in the same school as their peers.

Next Chief Witham reviews the requests for the Halifax Fire department. The first one is in the amount of \$17,300.00 from Fire Training into Fire Expenses. The reason for the request is due to additional costs related to unforeseen staffing changes. The department added new members and new custom gear was needed for each firefighter.

The following request by the fire department was in the amount of \$20,707.94 from the Fire Wages Part Time into the Fire Expense Equipment. This was caused by the purchase of necessary equipment that was over the projected budget. The department needed two chair lifts for the current ambulance fleet. The previous lifts were 8 & 12 years old, and they were unable to get needed parts or replacements anymore. This was a safety issue as the lifts are used daily.

OPEN MEETING LAW COMPLAINT: Todd states going forward he will now announce members are participating remotely as well as stating it is a remote meeting. This is in response to the recent complaint filed against the committee. Cody responded after the previous meeting to the first open meeting law complaint. Since then an additional complaint has been received. The individual stated the committee did not take a formal vote allowing the town administrator to answer on behalf of the Finance Committee. This was inaccurate as the committee did have a formal vote. The committee is now waiting for the Attorney General's office to respond and make a determination.

CORRESPONDENCE & AS MAY ARISE: Todd informed the members that he has received a resignation email from Johnathan Schmaling. The open position will be posted on the website on August 1st and will be open until the end of August. Caesar will post on the town pages and inform Todd once live.

The only correspondence in the mailbox at town hall was the annual dues invoice from the association of town finance committees' subscription for 2024. The cost of the annual membership is \$190.00 and comes out of the finance committee budget.
