Todd Dargie called the meeting to order at 6:05 pm

This meeting is being conducted remotely and being recorded by Area 58.

ACCEPTANCE OF MEETING MINUTES: Minutes from Monday July 17, 2023 have been circulated to the committee for a vote.

Todd entertained a motion to recommend the meeting minutes from Monday July 17, 2023

FINANCE COMMITTEE DISCUSSION AND VOTE FOR WILLIAM J SMITH'S APPOINTMENT: Todd begins with an open discussion from the committee members regarding the appointment of William J Smith to join the committee. Todd believes he would be a great fit for the finance committee with his years of experience as a police chief. Frank agrees and believes Mr. Smith interviewed well. He also believes his experience with municipal budgets will be beneficial to the committee. Jim states Mr. Smith would be a good candidate due to his experience. The only question Jim had regarding Mr. Smith joining the committee was being on the reviewing end of budgets instead of requesting. Cheryl also agreed with both the statements made by Jim and Frank. Overall, the committee agreed that Mr. Smith would be a beneficial asset to the committee.

TALENT BANK FORMS OF FINANCE COMMITTEE OPEN POSITION: The new vacant position was posted on August 1, 2023. As of today August 21^{st,} the committee chair has yet to receive any candidates. Todd encourages anyone interested in joining the committee to complete a talent bank form.

REAPPOINTMENT OF TODD DARGIE AS THE CHAIR OF COMMITTEE: Todd explained to the committee he is up for reappointment. The committee will need to make a vote to elect Todd to remain the chair of the committee. He turns the conversation over to Cheryl as the vice chair as he would need to abstain from the vote. Frank asked if they would make a quorum if Todd abstained his vote. Cody replied stating quorum would be based upon all committee seats therefore they would not. However, Sandy stated that in previous years the committee had made a vote that quorum would be filled based upon active members only. Cody was unsure and was going to confirm with council but instructs the committee to continue with the vote. If they need to have a revote at the next meeting they can re add items to the agenda for the following meeting.

OPEN MEETING LAW COMPLAINT: (OML 2023 – 119). Patrick Higgins stating the committee chair did not announce which members were participating remotely during the May 23, 2023 committee meeting. The Attorney General's office did respond with the following statement. "Video of the Committee's May 23 meeting clearly shows that at the start of the meeting, which was held entirely remotely with each Committee member appearing separately on screen by video, the Chair announced the name of each Committee member participating remotely. Nothing more was required."

The committee did receive an additional complaint from Mr. Higgins on July 25th. This involved the July 17, 2023 committee meeting on the candidate review on the agenda. Todd explains Mr. Higgins is correct in his complaint that we would need to disclose the candidates' full name, which we failed to do. Todd has taken steps to ensure that this will not happen again in the future. First the agenda has been updated to reflect full names going

forward. Second there is a new timeline for proper distribution of the agenda to committee members. On Monday night after the committee meetings the finance committee secretary will distribute a draft of the agenda to all members, the town administrator as well as the town accountant. This will allow everyone to have until the end of the day on Tuesday to review and revise the agenda before being posted. Then the finance committee secretary will be send to the Town Clerk's office at the end of the day on Wednesday.

The last step would be to have the committee members participate in an open meeting law training course. Once completed, a member will need to inform Todd and he will relay information to Cody.

Todd entertained a motion to recommend Cody respond to the opening meeting law complaint from July 17, 2023.
