 - A. Discussion and Vote to allow Director of Food Services and/or Superintendent of Schools to accept donations of food and money to support our Free and Reduced Lunch efforts with approval of the Chairman of the Silver Lake Regional School Committee.
 - B. Discussion and Vote to allow the Superintendent of Schools to exceed the FY'20 Food Service Budget and other lines associated with supporting our Free and Reduced Lunch efforts.
 - C. - E. Discussion and Vote to support the actions of the Superintendent of Schools to advocate for students to be exempt from high stakes testing required by Federal and State legislation including MCAS Testing and for students to be held harmless due to the COVID-19 State of Emergency.
- F. Discussion and Vote to support the actions of the Superintendent of Schools to advocate for Federal and State reimbursement for feeding students during the school closures due to the COVID-19 State of Emergency.
- G. Discussion and Vote of Support for the Memorandum of Agreements pertaining to the Silver Lake Aides and Silver Lake Education Association.
- H. Discussion and Vote to waive traditional graduation requirements in light of the COVID-19 State of Emergency and to allow the High School Principal the authority to work with individual students to ensure they graduate with their class.
