Halifax Beautification Committee – Meeting Minutes November 4, 2019

Called to order at 1:08 pm

In the Selectmen's Meeting room

Plastic Bag Bylaw: Passed the Halifax Business list around for sign ups. Each committee member initialed ten businesses to deliver a copy of the bylaw and the transition letter ("Tips for Establishments to Ease the Transition to the new Reusable Bag Bylaw)

Minutes

There was discussion of the minutes from the 10/21/19 meeting. Candace stated that she felt the wording of these motions was not correct:

- The reason why the Parks Dept would attend a meeting
- The motion made regarding Halifax Vendor Authority Signature process

There was discussion about the minutes, the Parks Dept and the vendor warrants.

At the end of the meeting a motion by Candy was made to reconsider the vote from 10/21/19 regarding the vendor warrants. Greg seconded the motion, and the motion passed unanimously.

Plastic Bag Bylaw Implementation

Discussed the bylaw implementation process. The master list of Halifax businesses was sent around (as earlier stated). Briefly discussed the bylaw and the handout (transition letter: "Tips for Establishments")..

Candy made a motion regarding Plastic Bag Bylaw Implementation: "Motion to approve the handout for businesses to facilitate transition to be distributed to as many Halifax businesses as possible prior to 3/1/20." This motion was seconded and passed.

Jeanne Kling donated a box of Nitrile Gloves that will be distributed on Fall Clean Up Day to participants.

Reusable Bags

Candy offered to research prices for reusable bags and the committee discussed a few ideas for bag designs. We decided on a green bag with the town seal and the implementation date: March 1, 2020. Motion made to order bags as follows: Amy made the motion: "The Halifax Beautification Committee authorizes Candace Kniffen to get a quote from "*Walker and Clay*" in Hanson and/or "*4Imprint*" online to purchase the reusable bags in an amount up to \$200.00 +/- IF the bags can be delivered by November 15, 2020." Nancy seconded the motion and it passed unanimously.
