Halifax Board of Health Meeting Minutes Wednesday, February 19, 2020

On Wednesday, a meeting of the Halifax Board of Health was held at the Halifax Town hall. **Present at the meeting were:**

The Board of Health meeting opened at 6:30p.m

1. Disposal Works Permits:

- a. Requiring <u>Local Upgrades & Variances</u>: (but otherwise recommended for approval):
 - i. <u>27 Holly Street</u>: Hearing 6:30pm: (Webby Engineering will be in attendance.
 - **1.** Allow the proposed septic tank and pump chamber to be 8' from a cellar wall instead of 10' required.
 - 2. Allow the proposed SAS to be 5' from a cellar wall instead of 20' required. (w/Impervious Barrier & Retention Wall)
 - **3.** Allow the bottom of the proposed SAS to be 3.1' from soil mottling instead of 4' required.
 - 4. Allow a 2' remove and replace instead of 5'.
 - 5. Allow the use of a sieve test to determine the L.TA.R.
 - 6. Allow a 25% reduction in the size of the proposed SAS.
 - **7.** Allow a 7' setback from the proposed SAS to a property line instead of 10' required.

 - **i.** Alan Dias updated the Board. Follow-up was done on the complaint. He spoke with owner regarding rerouting of ground water on said property.

3. Discussion Items:

- **a.** Walk-in Discussion:
 - i. <u>21 Ocean Avenue</u>: Property is part of the "*Systems around the Pond*" project. Owner Sheila Hart and her brother Robert Sweeney were in attendance.
 - 1. Mr. Sweeney stated he was a Title V Inspector and informed the Board that according to Ms. Hart's documentation, it shows a 1000 gallon holding tank to a 1500 gallon leaching pits, not a single cesspool indicating an automatic failure.
 - 2. The Board explained that the Board of Health can only go by the information they have in the property folder and the office does not have the document Ms. Hart is referring to. The only documentation the Board of Health has indicates a single 6 x 6 foot pit in the

driveway, installed in 1991. A copy of Ms. Hart's documentation was given to the Board of Health.

- **3.** The Board suggested Ms. Hart get a cursory inspection and submit a sketch of the actual system located on the property.
- **4.** The Board is in agreement that they are ok with Mr. Sweeney doing the inspection for Ms. Hart.
- **5.** Mr. Sweeney stated he will dig and sketch/drawing the septic system.
- **6.** The Board stated the sketch/drawing will need to be stamped with an engineer stamp. The Board also stated that the system needs to be pumped.
- **b.** <u>550 Monponsett Street</u>: Lakeside Villa: Update. Alan Dias updated the Board that the increase requested by Lakeside Villa was for the liquor license itself, not an increase in seats that would impact the septic.
