- **b.** <u>25 Ocean Avenue</u> Received 2022 Title 5 Report. Letter went out for annual water testing fee. (*See Discussion Folder*).
 - i. No response currently. Board discussed
- **c.**Covenant Cases: There are currently five (5) properties under said covenant. (See Your Individual Folder)
 - i. 22 Holmes Street
 - ii. 29 Lake Street
 - iii. 25 Ocean Avenue

 - ii. Covenant Cases get Title 5 Inspections due by the end of April and 2 samples for water testing taken in October each year.
 - 1. During a conversation with G&L Labs, the Board of Health was informed that the method of testing for the water samples being done is an old method and it is being eliminated as an option because of the possibility of false negative results in the presence of E. coli. This is the last year they will offer this method of testing.
 - 2. Due to technology change, the old method will be discarded, and a newer, more current method of testing will need to be used.
 - a. Currently the cost for 2022 is \$15.00 per sample. (\$30. annually)
 - **b.** The newer method of testing cost for next year will be \$41. per sample. (\$82. annually)
 - i. Agent and Board discussed. Agent provided supplemental documentation and information on Covenant Cases for the Boards review. Water testing, deed restrictions, and regular inspections.
- d. Agent Report:
 - i. COVID Update.
 - 1. Agent updated the 3-week run-rate for COVID-19 as 11.79%, 11.49% and 6.52% (current week). Agent recommends as always to take the proper precautions to stay safe and healthy, and to stay home if you are sick. The CDC encourages indoor masking in busy areas. The Board discussed and are hopeful that the public stay informed and the Virus gets weaker as it mutates and evolves.
