  - **a.** Town Hall Opening & Elections Health Agent updated the Board:

- i. The election is on June 20 in the gym and that is easier to accomplish safely than an annual town meeting.
- ii. The annual town meeting has been postponed until at least July 11th and may be outdoors.
- iii. Distancing and sanitizing will take place at the election.
- iv. Facial covering such as a mask is still in place.
- **v.** A lot of people are early voting and voting by Mail.
- vi. The Clerk's Office has a very detailed plan.
  - 1. If it's nice out the front door will remain open otherwise she has two helpers who are opening the doors for people and a side entrance door will remain
- vii. There will be taped markings on the floor.
- **viii.** The voting tables will be at least six feet apart.
  - 1. The check-in and check-out tables have Plexiglas with the hole at the bottom for passing papers.
  - 2. Everyone is given their own pencil and told to either keep it or toss it into a
  - 3. There will be 2 voting tables for people who do not have masks on and yes Shields can be used also.
  - **4.** There will be no use of fans:
    - **a.** Outdoors is better than indoors.
    - **b.** The gym is such a large room, people will not be there long and at least one door will be open if not two.
  - 5. The annual town meeting will require more planning.
