The Board of Health meeting opened at 6:30p.m

1. <u>Discussion Items</u>:

a. Landfill Erosion Repair:

- i. Update and RDA Legal Ad in PH Express on 10/16/20.
 - 1. Alan Dias updated The Board that he will be representing the Board of Health at the hearing on October 27, 2020.

b. 163 Plymouth Street:

 - ii. Orangeburg Piping Policy
 - iii. Dbox and Piping Policy
 - iv. Cast iron vs Plastic Covers
 - v. Mandate Soil Evaluations any system installed prior to May 1995.
 - **b.** Carry-over to next meeting.

 - 1. The Health Agent updated The Board that there has only been one complaint within the last two weeks regarding masks.
 - 2. The Board recommends locally enforcing masks along with the State Regulations, requiring every person to wear a mask when entering a food establishment or they will be denied admittance.
