
## MINUTES OF THE MEETING HALIFAX CONSERVATION COMMISSION

Present: Joe Webby/Webby Engineering representing owner

Halifax Plaza and Rockland Trust development. Received permission to put in siltation basins to take care of surface water run-off. Almost nothing done in 22 years, water is backing up to the edge of tree line and eroding pavement. Want to get to basins and clean it up, (vegetation). Did mark the BVW, limit of work will not go beyond basins.

Septic Plan from Board of Health pulled showing actual property.

Owner arrived: Marline Amedee -

Chairperson Evans asked owner about going in the BVW on property and bordering property that the town owns. Ouestioning if she has disturbed any wetlands

Ms. Amedee: advised that a neighbor told her about that. She said she did not go to (inaudible), and she was cleaning, and appealed to her (Ms. Renaud) that there is a lot of trash, beer cans, plastic bags on wetlands, and wanted to clean it and is on her own property. She told (Ms. Renaud) that (clear) that she wasn't cutting anything, just cleaning.

Chairperson Evans asked who she spoke to. (answer is inaudible)

G. Fitzgerald interjected asking how it all came forth: stating that someone report that she was clearing town owned land. Ms. Amedee said "Yes". Mr. Fitzgerald then stated picking up trash if fine. Ms. Amedee said there is still a lot of trash, stating it was almost a dump. They started to clean, did start to cut, but she was told (cutting branches) that she can't cut them. (noting neighbor told her in September of last year) Then neighbor called town hall. Again, stating last September was assisted with property lines, No one told her, so now knows and won't do it again. June of this year cleaning dead brush and trash, but left some due to conflict with neighbors, left the rest. Then received the notice.

Mr. Fitzgerald asked about the plan (Board of Health plan) and nothing is delineated. There is a 100' & 50' BVW noted on the plan. (basically right thru the middle and at back edge of Ms. Amedee's property) Members and Ms. Amedee reviewed plan. Former owner Conroy's property is to the rear which backs up to Birch St. Ms. Amedee stated she has some property that also backs up to Birch St. There was also some screening put up in the rear of property.

Ms. Amedee noted that there were two (2) big branches that feel in the back and had to cut them, also another one to the side. Mr. Fitzgerald advised of the 50' no touch is at the back of property. Maybe get property markers of the boundaries. Also, can't cut or clear debris if it's on neighbors' property. Fitzgerald showed her the plan explaining the 50' and buffer zone and can't go in, cut, clear, etc. Ms. Amedee believes she owns another lot in the back, connecting to Birch. Would need to get a plot plan showing all her parcels. Members again explained that even if its her property, if a tree falls inside the wetlands or 50' buffer she still can't do anything to it unless she files with the commission.

Secretary asked to get the commission a plan of all her properties and come back to the commission and can advise what and where she can do anything, but still need to apply (file) come before the commission if she wants to clear, remove brush, trees etc., within the 50' buffer.

Ms. Amedee said it is good to know and thanked the commission.
