Gordon Andrews called the meeting to order at 7:07pm.

Meeting was recorded by Area 58.

### Reserve Fund Transfer

A Reserve Fund Transfer was submitted by Charlie Seelig in the amount of \$1,591.36 to be transferred to the Law Account to pay Legal bills.

Melinda Tarsi made a motion to approve the Reserve Fund Transfer. Seconded by Stu Hall. Motion passed unanimously.

#### **Meeting Minutes**

Mel Conroy made a motion to approve the Meeting Minutes from 2/13/17. Seconded by Diane Ruxton. Motion passed unanimously.

Mel Conroy made a motion to approve the Meeting Minutes from 3/13/17. Seconded by Stu Hall. Motion passed unanimously.

#### Council on Aging

The Committee discussed the presentation that was given on Monday, 4/3/17 explaining the proposed addition to Pope's Tavern. Gordon Andrews would like to see it be listed in the Town Warrant as a recommendation from the Finance Committee at Town Meeting. This way the Committee can schedule another discussion for 4/10/17 and all of the members will have time to review the presentation that was recorded.

#### Wage and Personnel

The Committee went over the packet that was handed out, dated 4/4/17, and titled Recommendations FY18. Included in this handout were a breakdown of proposed changes to the Longevity benefits and a list of Article 2's subsections as they will appear in the Town Warrant.

(7) Who will decide who goes and serves as a member of the Board? Should it be a volunteer, a BOS decision? It was finally decided that it should be a joint vote between the BOS and the Finance Committee. The wording will be changed to read accordingly in the Warrant.

The changes to the Longevity benefits were based on the 10 benchmark towns and also 6 steps. The Longevity amounts have not been changed since 1994. Part time will be prorated. It will mean an additional \$9,340.00 to the budget for FY18. Currently if we go out to the full levy limit, we are \$672,772.00 below the levy limit. We are looking at an increase for the longevity of \$9,340.00 and an increase for contracts of \$45,745.00 along with a possible increase of \$47,126.00 for the 2% wage increase for wage and personnel employees only. That means over \$100,000.00 would come off of the levy, bringing it to about \$500,000.00 below the levy limit. If you take off an additional \$10,970.00 for an HR Manager position it gives you a total of \$113,181.00 additional. Marie Coady asked how many of the benchmark communities surveyed had an HR position. Diane Ruxton said that she believed two towns had HR Clerks. Marie wanted to know what made Halifax in need a HR position. Diane Ruxton explained that the needs of the town are what was taken into consideration in making the decision.

#### HR Manager Position

The addition of an HR Manager position is being proposed. The position is based on 28 hours and would be at a Grade 10. Right now the Assistant Treasurer spends approximately 24 hours per week on HR related business. Marie Coady asked if perhaps this position should be graded at a Grade 7 instead of a Grade 10. Charlie Seelig confirmed that the position would be a Grade 10. Mary Gravinese questioned why we were adding a position and Mel Conroy agreed with Mary. Kim Roy explained the job further. The Assistant Treasurer position would be eliminated and the funding for that position would be used towards the new HR Manager Position. It would be advertised, the current Assistant Treasurer was not guaranteed the job, although she was currently doing the work. The additional 4 hours would be absorbed by the Treasurer/Collectors Office. Mary asked for confirmation of the salary and the Grade 10 was confirmed.

#### Articles in the ATM

Article 2(1) – Mel Conroy made a motion to recommend a 2% wage increase. Seconded by Bill McAvoy. Gordon Andrews voted No. All other members in attendance voted Yes. Motion passed.

Yes: Melinda Tarsi, Gordon Andrews and Bill McAvoy No: Mel Conroy Abstain: Stu Hall and Diane Ruxton. Vote was 3-1-2 The Committee was unable to reach a unanimous decision so it is a No vote.
