## Mail

Wage and Personnel's FY19 Recommendations were received.

A letter was received about the numbers concerning Silver Lake.

#### Reserve Fund Transfer

A Reserve Fund Transfer was received from Charlie Seelig for \$4,500.00 to a separate account to cover appraisals of land that is coming out of Chapter 61A.

Mel Conroy made a motion to approve the Reserve Fund Transfer. Seconded by Bill McAvoy. Motion passed unanimously.

#### Wage and Personnel

The first three employees listed on the FY19 Recommendations came before the Board at an open meeting. In addition, the Recycling Coordinator was recommended by Don Jacobs. The board decided to put the rest of the requests on hold as there were many of them that followed. They looked at the figures and the hours as well. Sue Vogt looked at the 10 benchmark towns in order to compare but they did not have the job descriptions from the other towns, so they did not know if they were looking at apples to apples or apples to oranges in each position.

- 1) Diane Ruxton made a motion to recommend a 2% increase for all non-union Wage and Personnel employees. Seconded by Mel Conroy. Gordon voted NO. All other members voted yes. 3-1, motion passed by majority.
- 2) Diane Ruxton made a motion to recommend reclassifying the position of Health Inspector from a Grade 10 to a Grade 11. Seconded by Mel Conroy. Bill and Diane voted Yes. Gordon and Mel voted No. 2-2, motion failed.
- 3) Diane Ruxton made a motion to recommend reclassifying the position of Inspector of Buildings/Building Commissioner from a Grade 10 to a Grade 11. Seconded by Mel Conroy. Bill and Diane voted Yes. Gordon and Mel voted No. 2-2, motion failed.
- 4) Diane Ruxton made a motion to reclassify the position of Water Superintendent from a Grade 11 to a Grade 12a (Base Pay only). Seconded by Mel Conroy. Bill McAvoy abstained. Diane Ruxton voted Yes. Mel Conroy and Gordon voted No. Motion failed. Mel Conroy made a motion to reconsider. Seconded by Gordon Andrews. Motion passed unanimously. Diane Ruxton made a motion to reclassify the position of Water Superintendent from a Grade 11 to a Grade 12a (Base Pay only). Seconded by Mel Conroy. 2-2. Motion failed. Could not reach a majority decision.
- 5) Diane Ruxton made a motion to rename and reclassify the position Administrative Assistant Recycling Grade 6 to Recycling Coordinator Grade 7. Seconded by Mel Conroy. Vote was 2-2. Motion failed. Could not reach a majority decision.
- 6) Diane Ruxton made a motion to delete section C under Chapter 35, Section 27 as written in the warrant. Seconded by Mel Conroy. Motion passed unanimously.
- 7) Diane Ruxton made a motion to add section C under Chapter 35, Section 27 as written in the warrant. Seconded by Mel Conroy. Motion passed unanimously.
- 8) Diane Ruxton made a motion to replace the following under Grades and Step Grade Unclassified: Assistant Outreach Worker \$14.75 per hour with Assistant Outreach Worker \$15.54 per hour. Seconded by Mel Conroy. Diane, Mel and Bill voted Yes. Gordon voted No. Motion passes.
- 9) Diane Ruxton made a motion to add to Appendix A Section V as printed in the Warrant. Seconded by Mel Conroy. Motion passed unanimously.
- 10) Diane Ruxton made a motion to add to Appendix A Section V as printed in the Warrant. Seconded by Mel Conroy. Motion passed unanimously.
