Mail

Meeting Minutes

Budget

Silver Lake's budget is going up about \$1,000,000.00 on the Operating Budget at this time. About \$250,000.00 – \$400,000.00 will be our share of that on the Assessment. We should be expecting about \$25.00 per student on 2,000 students for HES. Silver Lake's public budget hearing is set for 2/8 at 6:00pm at the high school.

The biggest lines in the budget are expected to be Out of District SPED & Vocational Ed. The schools may dictate what is going to be possible. There is room in excess capacity but that would have to be a discussion with the Selectmen.

Sandy will add in lines to Article 5 for Debt on the School, Fire Suppression and Popes Tavern.

Insurance should be ok where it is.

Highway has submitted two budgets, one is level serviced and one is expanding the department. Steve will need to come in and speak to it.  
Water Department will be putting in an Article to pay off the Water Tower Debt.
