

Halifax Planning Board Meeting Minutes March 2, 2023

A meeting of the Halifax Planning Board was held on Thursday, March 2, 2023, at 7:00pm in the Great Hall at the Halifax Town Hall 499 Plymouth Street, Halifax, MA.

Members Present: Vice Chair Amy Troup, Clerk Rick Merry and Members Robert Gaynor and Brendon Elliot. Chair Mark Millias is absent.

Vice Chair Troup calls the Halifax Planning Board meeting into session, states members present and reads agenda into record.

Hearing

• 7:00pm - 0 & 314 Plymouth Street – To Construct a 70'x180' two-story, 25,200 total sf storage building in a commercial business zone.

Fredrick McCarthy was present to represent R&J LLC. McCarthy states they reviewed old meeting minutes from the Planning and Zoning Boards from the previous applicants and saw that there were three things that the Boards did not like. With that they updated their plans to try and meet the Boards needs. They moved the buildings off of Plymouth Street 400ft, instead of one large building they will have eight smaller buildings, and the buildings will be painted the New England Red barn look. Dennis Swart explains the structure of each building and provides a swatch of the material that will be used to construct the buildings. Swart discusses the lighting plan and how it will be dark sky compliant. He shows on the plan where the light will zero out around the property. Larry Silva states that their main goal with designing the layout was to not impact the properties of the surrounding areas. Silva discussed the stormwater draining plan and the direction of where the water will be flowing. The building size was reduced in order to accommodate fire access and make sure fire trucks could get around without any problems. The Board asks Silva some questions about the layout of the buildings, driveways, and drainage. Amy Troup reads an email from town resident Jeremy Gillespie into the meeting for record.

The floor was opened up to the residents. Howard Eastman, 224 Monponsett St, addressed his concerns about if the retention pond on the golf course will have to be larger. Peck answers the questions about the water flows and retention ponds. Brendon Elliott asks resident Tina Alger, 340 Plymouth Street, if she is okay with this plan so she will not be flooded out. She asks that there be maintenance done periodically. Alger states if there is no maintenance done then it will not work. Peck states they are improving the situation as it exists now and that they are going to maintain the ditches and that it is in their best interest as well. Alger asks if the big building could be moved to the front of the property, so she doesn't have to look at it in her backyard. Peck states that if they are able to, they will move it but right now it is not economically possible. Elliot suggested planting arborvitaes in front of the barn to block the view. Residents share their concerns about the landscaping and design of the buildings. The Board closes the floor and discusses amongst themselves the next steps for the applicants. Applicants cannot go to the Zoning Board or Conservation Commission without a decision for the Planning Board.

Silva requests to continue the public hearing until the peer review of the site plan is completed. Troup request to make a motion to continue petition #981 to March 16th at 7:30 PM Elliot makes the motion.
