

Halifax Planning Board Meeting Minutes April 6, 2023

A meeting of the Halifax Planning Board was held on Thursday, April 6, 2023, at 7:00pm in the Great Hall at the Halifax Town Hall 499 Plymouth Street, Halifax, MA.

Members Present: Vice Chair Amy Troup, Clerk Rick Merry and Members Robert Gaynor and Brendon Elliot. Chair Mark Millias is absent.

Vice Chair Troup calls the Halifax Planning Board meeting into session, states members present and reads agenda into record.

MOTION to accept the agenda: Merry SECOND: Elliot All in favor (4-0-0)

Hearing

0 & 314 Plymouth Street: Self-Storage and Rental Office.

Applicants discuss the plans for the water and how it will flow to the retention basins on the golf course. The only change from last meeting to this meeting was the refinement of handling the drainage on both sides to make sure abutters are satisfied with the stormwater management. The board discusses the stormwater management plan with the applicants. Applicants are on the agenda for the upcoming Zoning Board of Appeals and Conservation Commission meeting. Troup states that the applicants should get approval from the other two boards before giving the final approval. The Board states they will write a letter to both boards stating they will approve the special permit as long as the wetlands are okay, and they get their variances from the Zoning Board.

Elliot makes a motion in reference to the April 6, 2023, Silva Engineering Associates letter and list of outstanding requirements that applicants will come back for final approvals and signature. Inside those conditions are not only what is on the list outstanding, but largest building and that the maintenance in front of the drainage ditch is regularly maintained by the owners of the storage facility, Merry seconds.

Applicant discusses they need approval for the size of the two-story building. The Board states that it is not on the agenda and that they cannot act on it at this meeting. Since the applicant has to come back for final signatures the board will be able to vote on it then. The Board will grant a 45-day extension for the site plan and the special permit. Gaynor makes a motion to continue the hearing until April 20th at 7PM. Elliot seconds.
