

Halifax Planning Board Meeting Minutes September 21st, 2023

A meeting of the Halifax Planning Board was held on Thursday, September 21st, 2023, at 7:00pm in the Great Hall at Halifax Town Hall 499 Plymouth Street, Halifax, MA.

These minutes are an abstract of the Planning Board meeting held Thursday, September 21st, 2023, which are on file with the Planning Board Department and posted on the Town of Halifax website and Area58 Halifax's YouTube page.

Chair Millias calls the Halifax Planning Board meeting into session, states members present and read agenda into record.

Appointments/ Hearings:

- *Hearing Continued* <u>359 Plymouth Street</u> File # **22-SPR-231**
 - O Chair Millias recaps on the last meeting regarding the property of 359 Plymouth Street. There were questions/concerns that were addressed by Con Com, as well as abutters. The topic of Riprap being present on the slope was mentioned at the last meeting, and present at the meeting is Gabriel Padilla of Grady Consulting to provide details on that. He informs the Board that there is in fact riprap present in the current plans to mitigate that matter.

Millias states that Con Com addressed everything the Planning Board has been discussing thus far and approved the Site Plan with an order of conditions at their 9/5/23 meeting. He also states that unless anyone has anything else to say that has not already been brought up, he would like to entertain a motion for the Board to act on this. Once that has been done, they will no longer be taking any comments from the public; only from Board members.

Millias asks if anyone is prepared to make a motion.

Elliot asks if anyone in the audience has anything to add before they continue. The response is no.

MOTION was made to accept Petition # 22-SPR-231 for 359 Plymouth Street as discussed with the amendments/conditions that Con Com has set forth.

Millias asks if the Board has anything they would like to add before they vote.

Gaynor states that he believes the applicant has gone above and beyond to make sure everything has been done correctly and all concerns/issues have been remedied. He states that he supports this project. Millias adds to what Gaynor said, stating that this has been discussed at length, and he feels that everything has been done as it should. He calls the submitted plans/application "thoughtful", and states that he also supports this project.

Elliot states that he feels like a plan is in place with the way Con Com worded their conditions of approval, and that if there is an issue that arises, it will be amended quickly and will be satisfactory to everyone.

Millias requests a roll call vote amongst the Board.

- Kozhaya Nessralla is present at the meeting to discuss signage for his business.
 - Nessralla states that he would like to put the same sign he has at his Hemlock Road location at his 416 Plymouth Street location as well. He presents the board with photos of the sign, and states the sign is 48x40. He asks the Board what he needs to do to proceed. Millias states that it would be an addition/amendment to the original Site Plan for the business, and that the Board would just need to give verbal consent assuming it follows all building requirements and By-Laws are being followed. A building permit to place the sign where he wants it will also be necessary. Nessralla is advised to apply for the building permit and bring the Site Plan to the next meeting so they can see the placement of the sign and approve.
