

Halifax Planning Board Meeting Minutes December 7th, 2023

A meeting of the Halifax Planning Board was held on Thursday, December 7th, 2023, at 7:00pm in the Selectmen's Meeting Room Halifax Town Hall 499 Plymouth Street, Halifax, MA.

These minutes are an abstract of the Planning Board meeting held Thursday, December 7th, 2023, which are on file with the Planning Board Department and posted on the Town of Halifax website and Area58 Halifax's YouTube page.

<u>Members Present</u>: Thomas Millias, Chair, Amy Troup, Clerk, Richard Merry <u>Members Absent</u>: Robert Gaynor, Vice-Chair, Brendon Elliot, Member.

Chair Millias calls the Halifax Planning Board meeting into session, states members present and read agenda into record.

Hearings:

- Continued Hearing 314 Plymouth Street **Petition # 991:** Site Plan Review for a future Starbucks and Retail Auto Parts Store & Special Permit to allow a drive-thru restaurant.
- Chairman Millias states that the hearing that was scheduled for 12/7/23 will be extended to the January 4th, 2024, and will not be discussed at tonight's meeting.

MOTION to approve the extension for Petition #991- 314 Plymouth Street to the 1/4/24 meeting.

Chairman Millias asks the Board if they should sign the extension form at this time. The Board agrees. Troup notes that the box for a 30-day extension is checked off on the form, and wonders if the Board should make it a sixty-day extension to cover the hearing. Millias agrees there is no harm in making the extension for 60 days rather than 30 days. Millias states there is a motion on the floor, and an amended motion would need to be made. Troup states she thinks they should continue the hearing itself to January 4th, but extend the Site Plan Review to January 30th, 2024, to cover all bases. **Amended motion is to read as follows:**

 - Chairman Millias states that the Town of Halifax has never accepted the road in question within the subdivision of Highland Circle, and that there seems to be some continued issues with the drainage easement. Highway Surveyor Steve Hayward forwarded some information and photos to the members of the Board. Upon doing some research, he was able to find out that the town is still holding a cash bond for \$10,000. Millias also states that he was trying to find some information on the developer but has been unsuccessful in locating a name or any pertinent information. He is going to try and reach out to the Engineer to see if he can obtain some contact information, so they may work towards getting the bond released and the necessary work finished. Abutter Isabel Simoes will be contacted when more information becomes available, and this will be added to the agenda of the next meeting for further discussion.
