 - DEP received a complaint from an abutter of 250 Lingan Street/Morse Brothers Bog alleging that dirt/manure is being dumped/stored on the drinking water wells at the property and alleges that it is affecting their water.
 - Branden Costa, DEP, Conservation Chair Evans, Health Agent Valery and Brendan Moquin, Controller for Morse Brothers conducted a site visit on 10/04/2023.
