- <u>Hemlock Lane Landfill</u>: Repairs needed. Possible RDA required.
- <u>Solitude</u>: *NOI*: Monponsett Ponds:
  - On behalf of their client "The Friends of Upper Mystic Lake", Solitude Lake Management, would like to request a three-year extension to the current Order of Conditions, DEP File # 346-379, for the continued maintenance of the aquatic vegetation in Upper Mystic Lake. This Order is due to expire on September 2nd, 2023.
- <u>23 Richview Avenue</u>: Resident believes more conditions should be added to the approved DOA from 2022.
- <u>383 Monponsett Street</u>: Driveway Installation Complaint.
  - Per discussion at 07/18/23 meeting, Administrative Assistant emailed after-the-fact RDA with links to the Wetlands Protection Act/Waterways Program as requested.
    No response from homeowner.
- <u>Docks</u>: Update: Draft "Dock Policy" sent to Town Administrator for review.
- <u>0 Pine Street & 1 Snow Street</u>: Update: Ongoing operation and storage. With Town Counsel.
  - Owner, Chair and Co-Chair are arranging a date and time to do a site-visit.
