- Conservation received a call from DEP 03/19/24 stating they received a complaint that the excavator is parked dangerously close to the lake and that there is a large pile of sand which is uncovered.
- <u>40 Old Summit Street</u>: Co-Chair Lane met with Greg Maroney, Maroney Building & Contracting on 03/09/24 for the pre-work site-visit.
- 48 Elm Street: Pond/Perennial Stream Complaint Cont'd.
 - At the Conservation Commission's 03/12/24 meeting, Member Martin-Plant offered to residents present at the meeting to reach-out to DEP regarding the pond/perennial stream matter at the property. DEP responded.
- Fuller Street: Illegal Dumping Complaint.
 - O Admin. received a call from Jeff Hunter, MDEP Solid Waste Department. They stated MDEP received an anonymous complaint regarding illegal dumping on Fuller Street. It is near the Halifax/Plympton line located in a field/meadow and wetlands. They stated that the complainant listed 2 armchairs, an air conditioner, and several gates.
- <u>471 Monponsett Street:</u> Complaint: Resident complaint regarding the trash/appliance/junk build-up at property.
 - At the Conservation Commissions 03/12/24 meeting, the Board voted to send a certified letter to the owner/resident requesting their attendance at a meeting to speak with the Board.
