## THE TOWN OF HALIFAX'S COMMUNITY CHOICE POWER SUPPLY PROGRAM CONSUMER NOTIFICATION

The Town of Halifax is pleased to announce that **First Point Power** ("First Point") has been selected as the supplier for its Community Choice Power Supply Program ("Program"). First Point will provide electric power supply for all consumers participating in Halifax's Program. This notice is intended to tell you about this Program for electric power supply. In accordance with state law, it also informs you of your rights and options if you choose not to participate in the Program.

YOU WILL NOT NOTICE ANY CHANGE IN YOUR ELECTRICITY SERVICE. You will see First Point printed under the "Supply Services" section of your monthly bill. You will continue to receive one bill from National Grid. You will continue to send your payments to National Grid for processing. National Grid will continue to respond to emergencies, read meters and maintain the distribution and transmission lines. Reliability and quality of service will remain the same. Furthermore, you will continue to have all existing consumer rights and protections.

**PARTICIPATING CONSUMERS** will start accruing at the aggregation rate beginning on the day of the month in September 2023 that their meter is read. This date varies by service area. Your meter reading date is shown on your bill.

**IF YOU ARE A BASIC SERVICE CONSUMER WHO HAS BEEN MAILED A NOTIFICATION** you do not need to take any action to participate. You will be automatically enrolled. If you do not wish to participate, please follow the instructions specified.

**OPTIONAL GREEN PRODUCT** – You may OPT-IN to the 100% renewable product <u>at any time</u> by visiting <u>colonialpower</u> <u>group.com/halifax</u> or calling First Point at (888) 875-1711 and asking to be enrolled. Halifax's Optional Green Product provides 41% National Wind RECs above the state's then-current minimum requirement for renewables [59% in 2023].

**IF YOU WISH TO JOIN THIS PROGRAM** you may OPT-IN at <u>colonialpowergroup.com/halifax</u> **OR** call First Point at (888) 875-1711 and ask to be enrolled. If you are currently contracted with your own competitive supplier, you should confirm with them that you will not incur any early termination fees or penalties for leaving their supply.

**IF YOU DO NOT WISH TO PARTICIPATE** you must OPT-OUT at <u>colonialpowergroup.com/halifax</u>, click the OPT-OUT button and follow the instructions specified **OR** call First Point at (888) 875-1711.
