Vice-Chair Kozhaya Nessralla calls the meeting to order at 7:18pm and informs the audience that the meeting is being recorded.

7:00pm – Hearing (Continued) – Petition #984 – James Rodriguez, 9 Lake St – Special Permit & Variance to raze and rebuild home

Hearing was continued from last month's meeting. The Board reached out to Town Counsel after the previous meeting but has not heard back yet. The applicant will build on the same footprint of the existing dwelling. The Board wants to hear from Town Council before making a decision on the petition. Applicant is going to bring in ZBA decisions over the last 10 years that have increased square footage with a special permit or variances so the Board can assess.

Kenyon makes a motion to continue the hearing until June 12, 2023, awaiting a response from Town Council. Durgin seconds.

The applicants requested a continuance last meeting since they weren't sure if they would get a favorable ruling from the Board. The applicant thinks that the proposed project would not be detrimental to the area and would not cause major traffic concerns. The applicant compares the size of the proposed project to other existing commercial buildings in the area. The landscape design was updated from the last hearing. The board discusses the aesthetic of the building and if it will fit the look of the surrounding buildings. Kenyon makes a motion to accept petition #986 with specific conditions. No storage of fertilizer and/or hazardous materials, no fuel torage, hours of operation in the summer 7AM to 5PM, change the facade to look more like a farmer's porch, and no porta potty storage.
