

Halifax Zoning Board of Appeals Meeting Minutes July 10, 2023

The Halifax Zoning Board of Appeals held a public meeting/hearing on Monday, July 10, 2023, in the Board of Selectmen's Meeting Room at Halifax Town Hall, 499 Plymouth Street, Halifax, MA with the following Board members in attendance: Vice Chairman - Kozhaya Nessralla, Members - Robert Durgin and Tina Kenyon; Associate Member - Marline Amedee. Vice-Chair Kozhaya Nessralla calls the meeting to order at 7:05pm and informs the audience that the meeting is being recorded.

Appointments

7:00pm – Hearing – Petition #993 – Scott Clawson, 21 Plymouth Street – Special Permit for 2 storage buildings
 (Filed: 5/24/23)

The applicant, Scott Clawson, is looking to put two storage buildings on the property. Buildings will be solely used for storage of farming equipment and plants for events. There will be lights in the buildings but no facilities. Neither of the buildings would be visible from the street. An abutter spoke of her concern regarding the number of buildings on the 100 acres of land. She also speaks concern about how the property becomes noisy with the events that take place. The Board has no comments for the applicant.

7:10pm – Hearing – Petition #994 – Daniel Kennedy, 416 Plymouth Street – Special Permit for dog daycare (Filed: 6/13/23)

The Applicant, Daniel Kennedy, is looking to do doggie daycare in the 3600 sqft space. The facility would be both a daycare and training. The hours of operations would be 7am to 7pm. There will be a short window for dropping off in the morning and picking up in the afternoon. Staff will also pick up and drop off at clients' houses. There will be no housing overnight. The waste will be double bagged, thrown away in a dumpster outside, and picked up weekly. The Board asks if he has a floor plan of the proposed layout. The applicant is waiting for a floor plan from the landlord to construct a layout of the space. The landlord did not want to get a floorplan from the engineer until the applicant was approved by The Board. There will be a maximum of forty (40) dogs at one time with twenty (20) individual resting cages. The dogs will rotate throughout the day so not all forty dogs will be resting at the same time. The Board would like to see a floor plan as far as how much space the dogs will have. There were problems in the past with kenneling and they do not want to see those problems happen again.
