

HALIFAX ZONING BOARD OF APPEALS Meeting Minutes Monday, July 9, 2018

The Halifax Zoning Board of Appeals held a public hearing on Monday, July 9, 2018 in Meeting Room #1 of the Town Hall with the following Board members in attendance: Robert Gaynor, Kozhaya Nessralla, Gerald Joy, Robert Durgin and Daniel Borsari. Peter Parcellin was absent.

Chairman Gaynor calls the meeting to order at 7:01pm and reprises the audience that this public hearing/meeting is being audio taped. He also explains the procedure and the protocol at the public hearings.

Mr. Gaynor welcomes Hiep and reads into record the Public Hearing Notice from June 4, 2018 into record. Hiep confirms that Attorney Alfieri is not coming. Mr. Gaynor confirms that the Board has read both Town Counsel's opinion (Attorney Amy Kwesell) and Brooks and DeRensis (Attorney Kim Saillant)'s opinion. Mr. Piccirilli asks if Attorney Alfieri is still representing the Phams. Hiep answers that yes, Mr. Alfieri is still representing them however he didn't feel Mr. Alfieri was needed at this meeting. The Board and Mr. Piccirilli feel that Attorney Alfieri, as he presented the Petition from the beginning and in order to avoid any confusion, should be present since there are still some concerns that need to be addressed regarding encroachment. Mr. Gaynor explains this to Mr. Pham and lets him know that it is recommended by the Board to continue until August when Mr. Alfieri can be present. Mr. Pham understands and will let Mr. Alfieri know to contact the Zoning Board Secretary as soon as possible for a status update.
